

Figure 1. The effect of the concentration of the *Agrobacterium* suspension on the transformation efficiency of *Agrobacterium* strains. The *Agrobacterium* strains were grown in the medium containing 100 mg/l of tetracycline. The cell concentration of the *Agrobacterium* strains was adjusted to 100 mg/ml. The cell suspension was mixed with the plant tissue and the mixture was incubated for 24 h. The plant tissue was then cultured on the medium containing 100 mg/l of tetracycline. The transformation efficiency was determined by the number of colonies on the medium containing 100 mg/l of tetracycline. The data are the mean \pm SD of three independent experiments.
