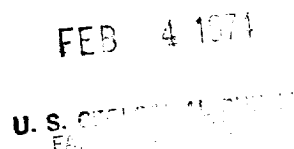
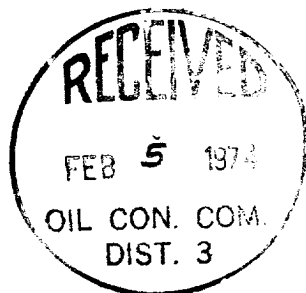

I would like to take this well from the shut in status and began pumping it again. The rods and pump where stuck due to gyp and rod scrappers. The casing has collapsed at approximately 190 ft. from bottom, therefore, the tubing was also stuck at this depth. Recovered all the rods and bottom - hole pump and all but 190 ft. of tubing. The well will now produce at 1090 ft. at 5 bbls. oil per day and 48 bbls. water per day.
