We plan to plug and abandon the subject well as follows:

Run in hole with bridge plug, set @ 1350'. Place cement on top of bridge plug to cover perforation top to 1150'. Perf 4 1/2" csg @ 80'. Place cement plug inside and outside from 80' to surface. Erect dry hole marker. Rehab surface.
