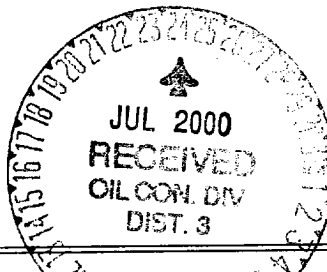

We plan to plug and abandon the subject well as follows:

Run in hole w/ bridge plug, set @ 1300'. Place cement on top of bridge plug to cover Gallup top to 1200'. Perf 4 1/2" csg @ 78'. Place cement plug inside and outside from 78' to surface. Erect dry hole marker. Rehab surface.
