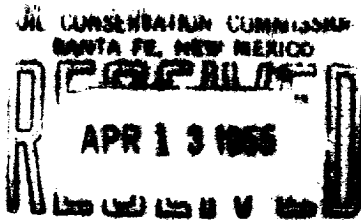

Gentlemen:

Aztec Oil & Gas Company hereby submits its application for administrative approval of a non-standard gas proration unit comprising all of Section 11, (lots 1, 2, 3, 4, ~~5, 6, 7, 8, 9, 10, 11, 12~~), Township 32 North, Range 12 West, N.M.P.M., San Juan County, New Mexico, and in support thereof respectfully states and shows the following:

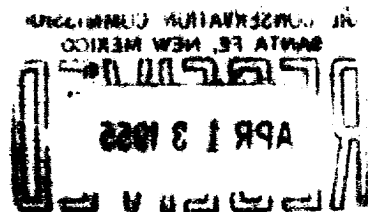
1. That the Aztec-Hubbard No. 2 well, located 990 feet from the South line and 990 feet from the West line of Section 11, Township 32 North, Range 12 West, was completed August 7, 1951 as a gas well and connected to Southern Union Gas Company's pipeline on October 10, 1951.
2. That the proposed non-standard gas proration unit consists of 336.40 acres which are contiguous quarter-quarter sections and lots.
3. That the proposed non-standard gas proration unit lies wholly within a single governmental section.
4. That the proposed non-standard gas proration unit may reasonably be presumed to be productive of gas.
5.
