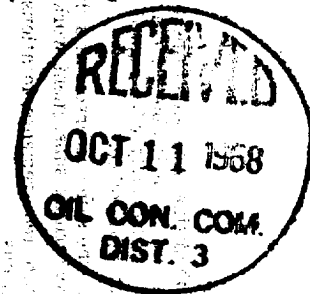

A 7 7/8" hole will be drilled to approximately 30' and 5 1/2" csg. run and cemented to surface. A 4 3/4" hole will then be drilled with air to approximately 1650' to test the Dakota formation. If commercial production is indicated, 2 7/8" bbg. will be run and cemented and the well completed.

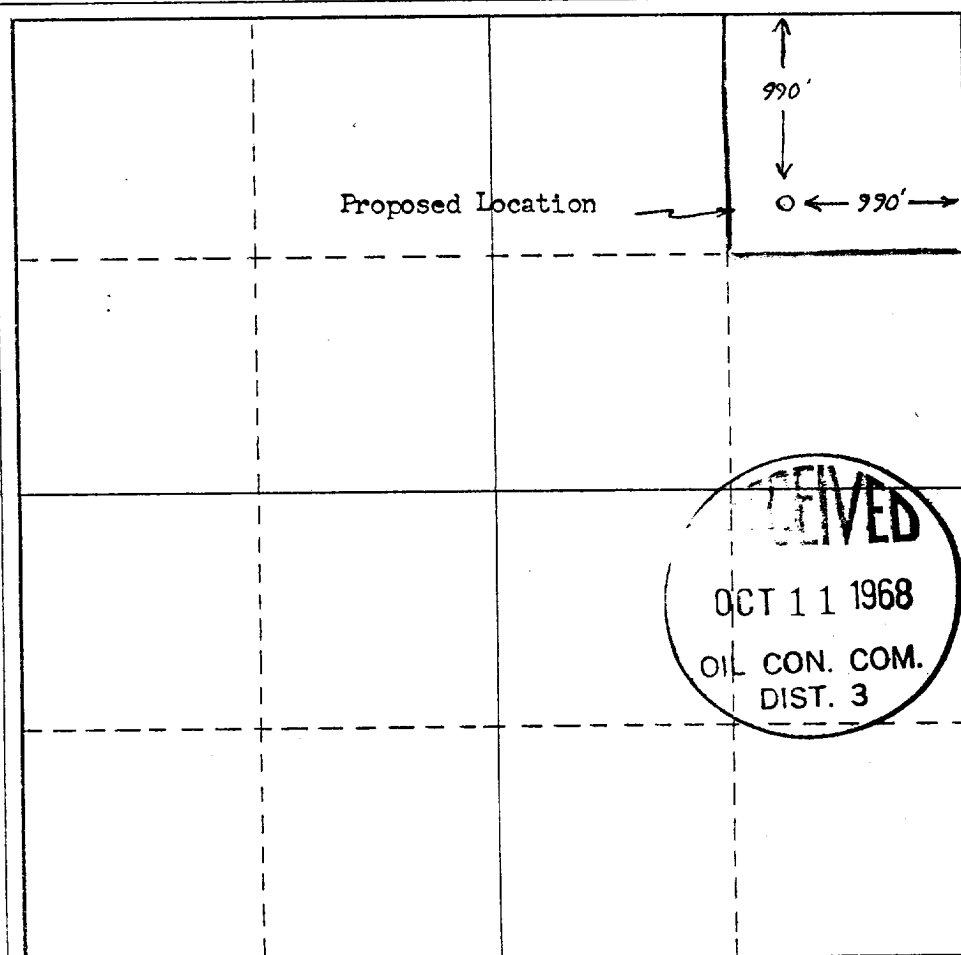
