An 11" hole was spudded 12:15 a.m., November 29, 1972, and drilled to 604'. Ran a hole opener and reamed a 15" hole to 604'. On December 1, 1972 the 10-3/4" casing was set at 604' with 500 sacks Class "C" cement with 2% CaCl₂. The cement circulated. The hole was reduced to 7-7/8" at 602'.
