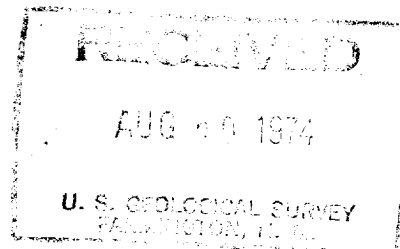

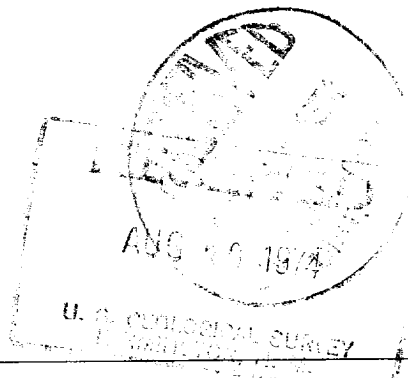

6-28-74 TD 2560' RKB. Ran 83 joints 2558' of 7" casing (58 joints 17#, 25 joints 23#), landed at 2555', cemented with 122 sacks 65/35 Pozmix, 10% gel, 12# Gilsomite per sack, and 150 sacks Class A cement with 12# Gilsomite per sack.

6-30-74 Pressure tested 7" casing to a 700# psi. Shut in at 650#. With drill pipe rams on blow-out preventer leaking slightly pressure decreased to 615# in 5 minutes.
