Well is presently tied into a gas sales line, however, pressures are too high to allow it to produce.

Well is located 90' from Storey #1A and 180' from Storey #2 which are currently on production and gauged 4 times a week. Storey #3 is monitored at that time, thereby allowing any leaks to be detected on a timely basis.
