5-18-77 Ran 68 jts of 4-1/2", 9.5#, LS, 8rd casing. Total 2509.28', shoe set at 5347', float collar at 5346', liner hanger at 2823.12'. Proceeded cmt with 20 bbls gel water. Cemented with 316 sacks 50/50 Poz A, Class B with 2% gel, 6.25# fine gilsonite per sack, 1/4# gel flake per sack and 0.6% D-60. Plug down at 8:00 AM 5-19-77.

Instructions
