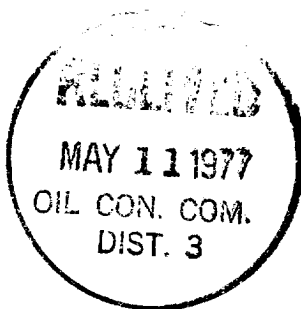

Cement circulated to surface.
