This is a request for administrative approval for an unorthodox gas well location in the Blanco Mesa Verde pool.

It is intended to locate the El Paso Natural Gas Company Rincon Unit #79A at 1110' from the North line and 730' from the West line of Section 17, T-27-N, R-6-W, Rio Arriba County, New Mexico.

Topography reasons make it impossible to build a standard location (see attached plat).

All operators of proration units offsetting the proposed unorthodox location have been notified of this application by certified mail.

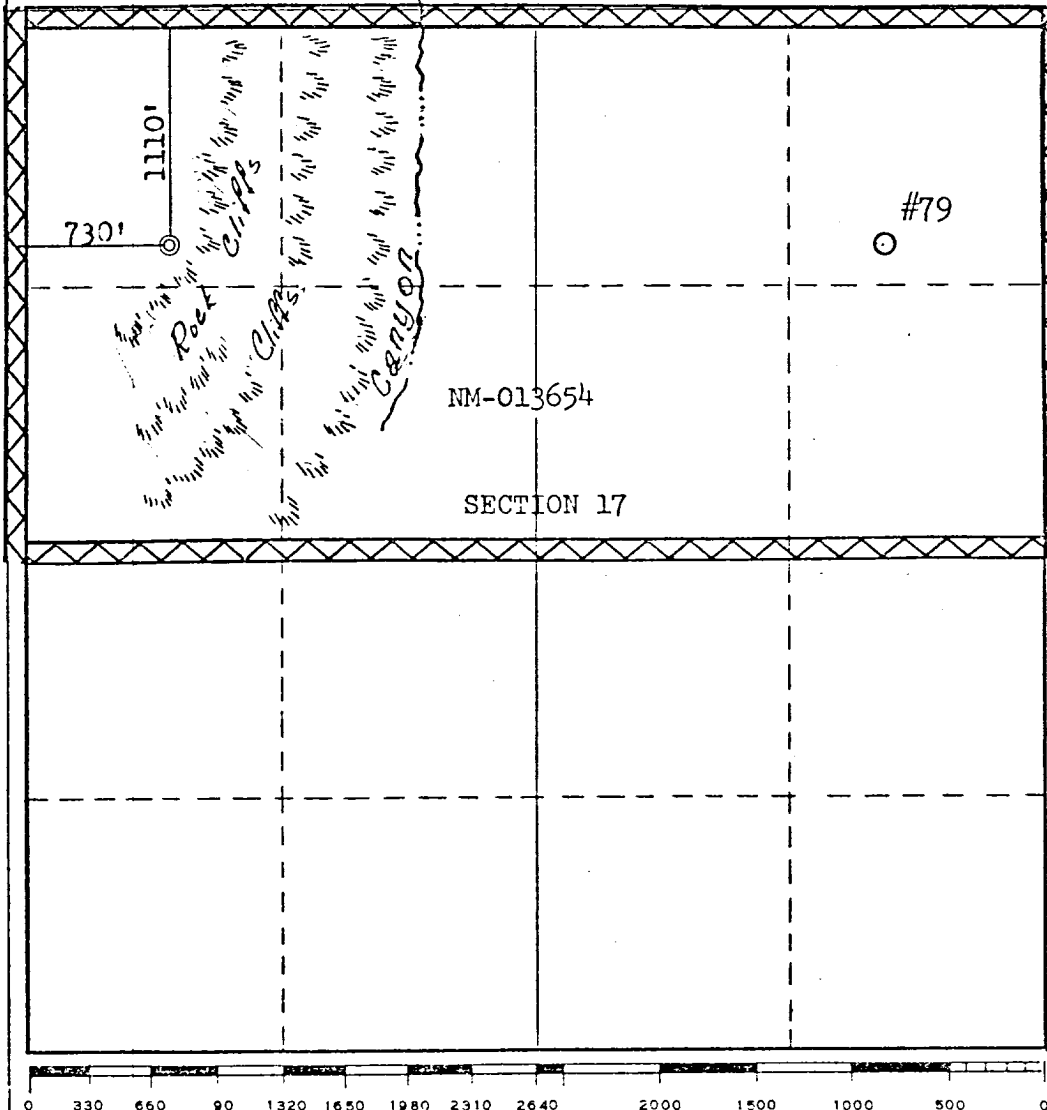

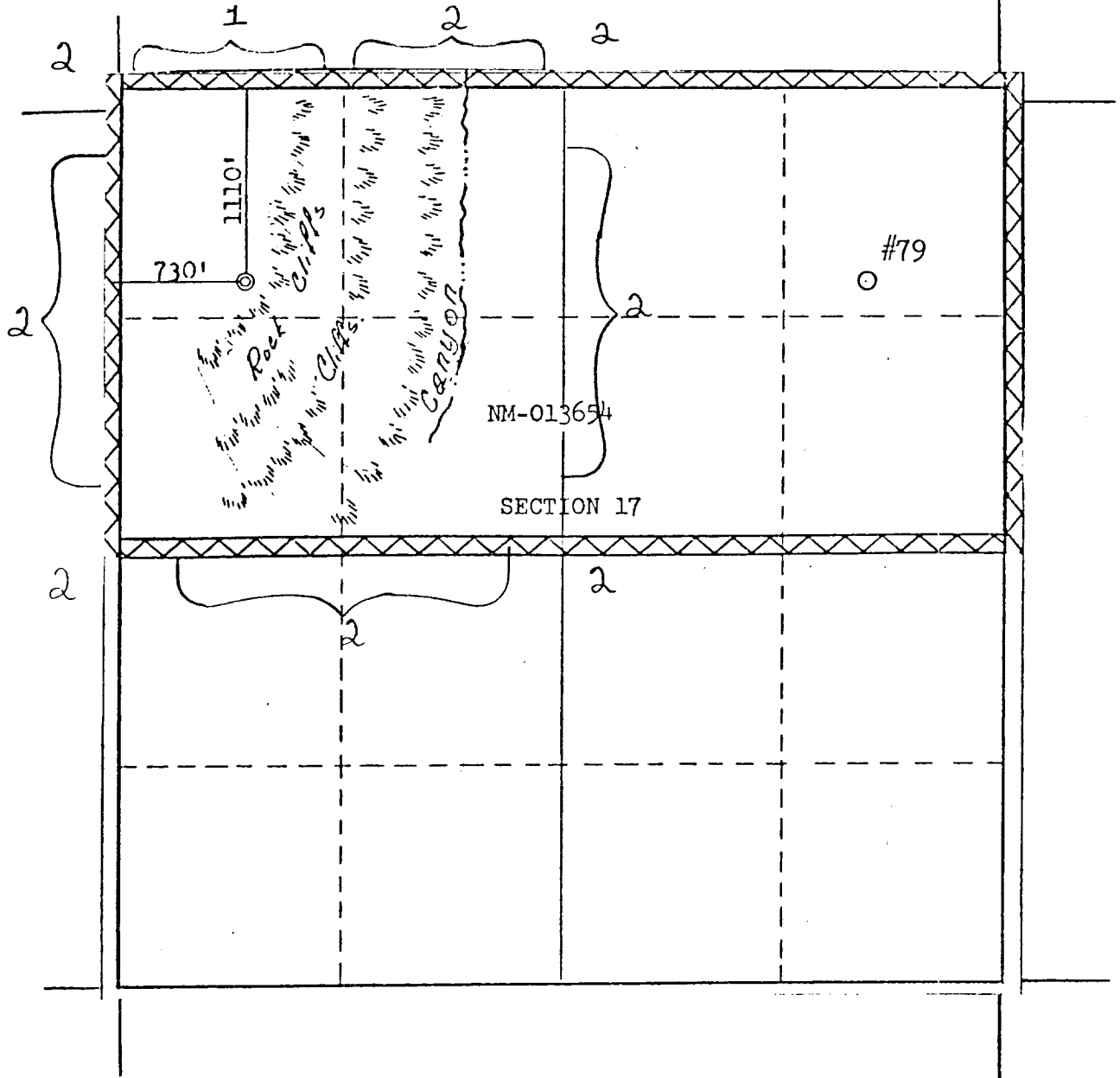
