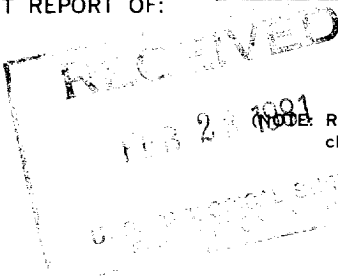

2/5/81. TIH w/bullplug, perf'd sub, SN. pump out plug and 2-3/8" tbg. Landed Mesaverde production string @ 4607'. NDBOP. NUWH. RDMOSU. RU and retrieved circulating blanking plug. RU Halliburton N₂. Pumped out plug. Kicked Mesaverde around w/N₂. Mesaverde flowing to clean up.

Instructions
