Set 9 5/8" 36# K-55 surface casing at 277' . Cemented with 200sx class B W/2% CACL2 . Circulated 11 BBLs to the surface.  
Pressure tested casing to 1000 psi. Drilled a 8 7/8" hole to a TD of 2434' on 12-4-90 . Set 7" 23# K-55 LTC production casing at 2431' . Cemented with 400sx class B Western 65/35po2, tail with 100sx class B Western . Circulated 29 BBLs good cement to the surface.
