

Re: Use of Nonpotable Water from a Deep Aquifer for Agricultural Purposes

Dear Mr. Kalka:

I am writing at the request of Dr. William M. Turner, Natural Resources Trustee for the State of New Mexico. You have inquired whether highly saline water produced with oil and gas from deep underground aquifers may be used for agricultural purposes, and if so, what regulatory requirements might apply. Dr. Turner asked me to respond to your inquiry.

The State of New Mexico regulates the use of groundwater in "declared basins." Under NMSA § 72-12-1, the State Engineer may declare underground basins having "reasonably ascertainable boundaries" to be public waters subject to the regulatory jurisdiction of the State Engineer's Office. Most of the groundwater in the State lies within a "declared basin." Under NMSA § 72-12-1, any person, firm or corporation desiring to use groundwater from a declared basin must apply to the State Engineer and receive a permit. The applicant must demonstrate, in accordance with NMSA § 72-12-3, that it will put the water to a beneficial use. Beneficial use is the basis, the measure, and the limit of the right to the use of water. N.M. Const. art. XVI, § 3; NMSA § 72-12-2.

However, under NMSA § 72-12-25, a declared basin does not include nonpotable groundwater from a deep aquifer. This exception applies only to water containing dissolved solids at a level of 1000 parts per million or more, and only to water taken from an aquifer the top of which is 2500 feet or more below the ground surface.

Thus, if the water you wish to use meets both these conditions -- contains at least 1000 parts per million dissolved solids and comes from an aquifer the top of which is at least 2500 feet deep -- the use of such water is not subject to the State Engineer's regulatory jurisdiction. No permit from the State Engineer would be required, and no showing of beneficial

use would be necessary.

The State of New Mexico also regulates the discharge of contaminants into underground waters. The Water Quality Control Act, and the Water Quality Control Commission regulations adopted thereunder, exempt the discharge of water for agricultural purposes. NMSA § 74-6-4(K); 20 NMAC § 6.3105(C). Thus, a discharge permit from the New Mexico Environment Department would not be required.

However, New Mexico does regulate discharges of water produced in connection with exploration for and production of oil or natural gas under the Oil and Gas Act, NMSA §§ 70-2-12(B)(15). Thus, a permit from the Oil Conservation Division of the Energy, Minerals, and Natural Resources Department would be necessary for any discharge of such water.
