THIS GROUND BED WILL HAVE A MINIMUM OF 20' OF 8" PVC SURFACE CASING. ALL WORK TO BE PERFORMED ON LOCATION/PLOW'S AND/OR PREVIOUSLY DISTURBED GROUNDS. NEGATIVE CABLE TO TIE IN CULPEPPER MARTIN 106.
