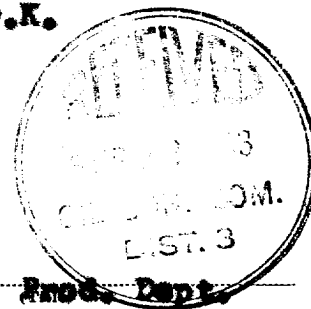

9-7-53 Ran 152 joints of 20 & 23 7" O.D. New Seamless 8rd. thd. J-55 ST&C R-2 casing. Casing landed @ 4726.93 from K.B.

9-7-53 Ran 180 sac regular Southwestern Portland bulk cement, 45 sac strata crete and 6 1/2 gal in 22 min. Circulation good. Bumped plug in 35 min. with 1100# pressure. WOC 3 AM.

9-9-53 Tested with 750# pressure. 4 hr. dry test. Both O.K.
