


# NEW MEXICO OIL CONSERVATION COMMISSION

**Oil String:** Ran 153 Joints of New seamless Youngstown and Valley Steel 23 and 20#, J and N casing, R 1 & 2 & 3, 8 rd thd. Landed from K.B. 4988. CEMENTED WITH 180 sax of southwestern portland, 45 sax of ~~High~~ Strata crete 6% Gel. Good circulation, WOC at 3:30 A.M. 8-10-53

Tested casing with 750# clear water pressure for 30 minutes. Also blew hole dry and got 4 hour dry test after drilling 5 feet below the shoe. Test O.K.
