1. MIRU PULLING UNIT.
2. NDWH / NUBOP.
3. PU AT LEAST 2 JTS. OF TBG. - TIH TO TAG FOR FILL.
4. TOH STANDING BACK 2-3/8" TBG. (TBG. IS SET @ 3201', THERE ARE 102 JTS. OF 2-3/8" 4.7# J-55 WITH F-NIPPLE @ 3168').
5. PU 4-3/4" BIT ON TBG. AND TIH TO COTB. CIRC. HOLE CLEAN.

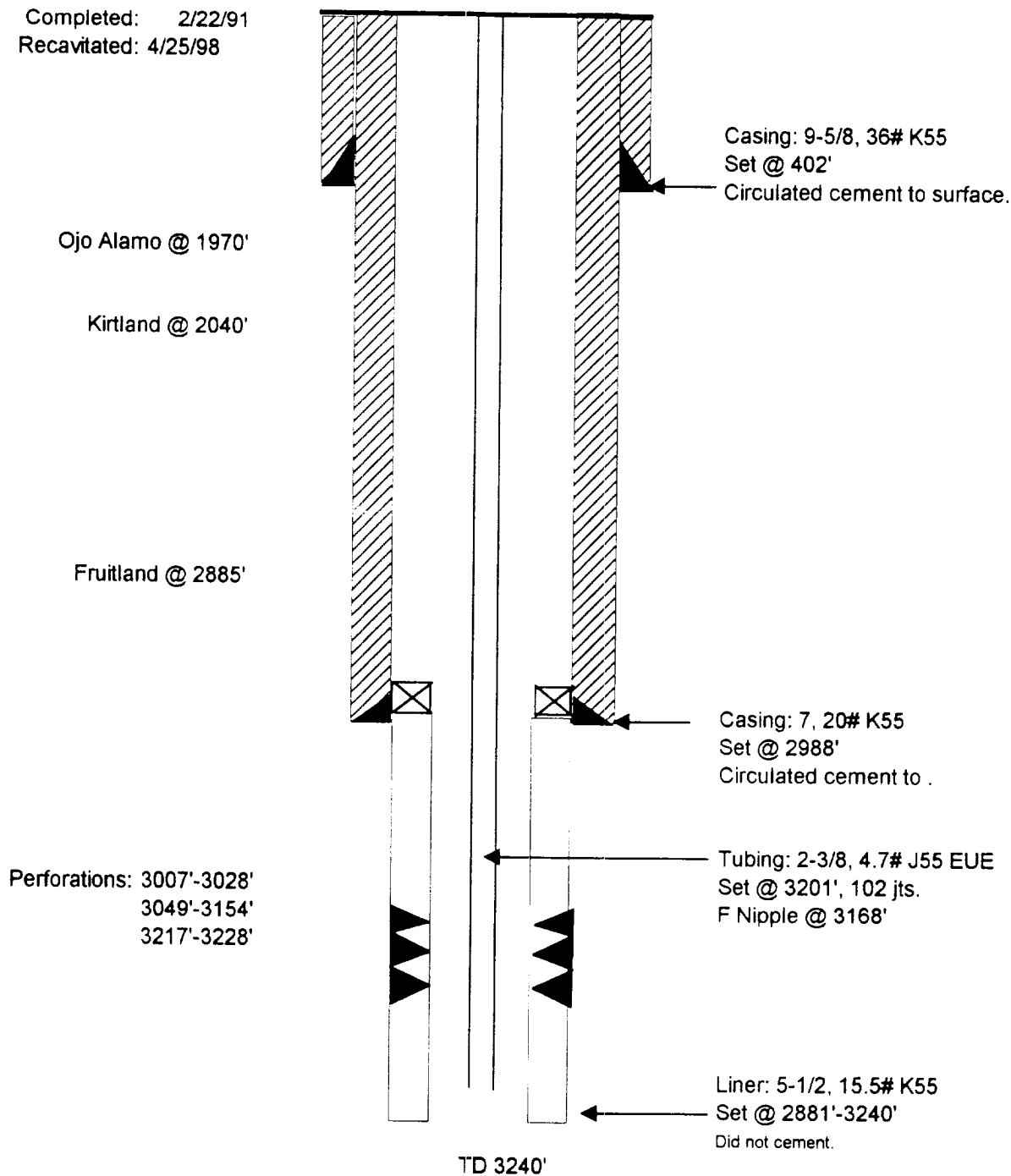
