Test: 300' Mesaverde (KMR) -

Should we hit oil, when + if we drill, we plan to set 50' 9 5/8" surface casing, and set it with 8SKS of cement. When + if we complete we will set 2 7/8" tubing 15' then run production sands (if any), and cement them on production sands with approx. 3SKS of cement. We plan to then separate our production zone (if any) with 1 barrel + 1 gal of oil on the separating gun to clean our sands. Then, we plan to set the pump & tank, if necessary - Our hole size is 4 3/4" -

I understand that this plan of work must receive approval in writing by the Geological Survey before operations may be commenced.

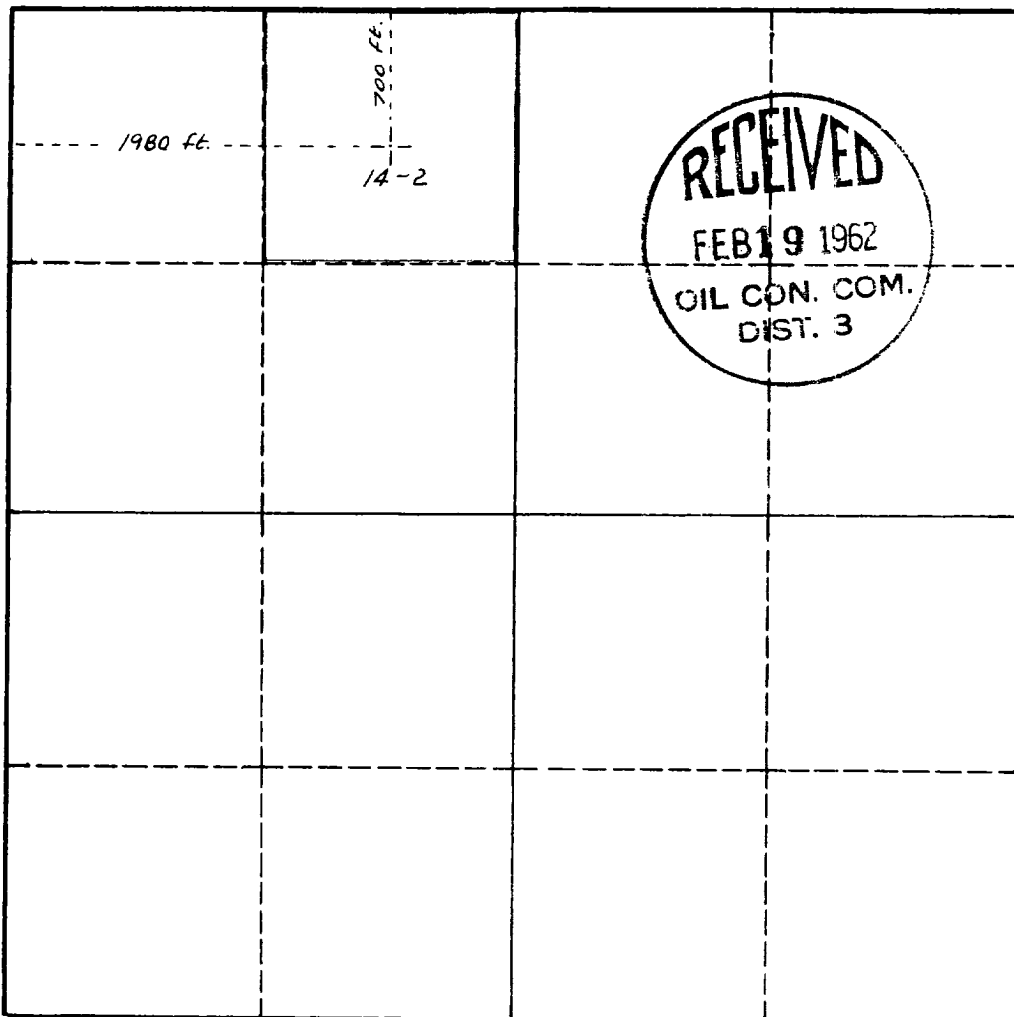
