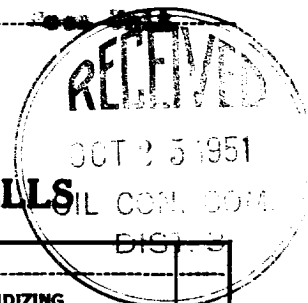

DETAILS OF WORK

Reference is made to Form 9-331a, approved November 14, 1949, temporarily abandoning well after testing Mesa Verde and Alvarado Cliffs formations which were found dry.

It is now proposed to move in cable tool rig, wash down casing, perforate 4-5/8" casing with one shaped charge per foot from 2990-3115 feet and test in an effort to determine productivity of Fruitland formation.

I understand that this plan of work must receive approval in writing by the Geological Survey before operations may be commenced.
