Release Remediation Plan Quarterly Update**


Dear Ms. Jones:

Gordon Environmental, Inc (GEI), on behalf of Sundance Services, Inc. (SSI), is providing this quarterly update on the implementation status of the Release Remediation Plan approved by the Oil Conservation Division (OCD) on February 17, 2016. During our most recent site visit on March 23, 2016 we reviewed the following efforts SSI has undertaken to date:

1. Significant efforts have been undertaken to reduce the spill containment footprint of the release within the smallest area possible with as identified in Attachment 1;
2. Reinforcement of the levee containment of Pond 2/3;
3. Continuation of contaminated water removal (an additional 21,000 BBLS have been removed for treatment and disposal offsite);
4. Reinforcement of the levee containment of Pond 1;
5. Continuation of contaminated soil removal (an additional 840 CY have been removed for disposal in the onsite landfill).

The Release Remediation Plan identifies Milestones for the approved remediation activities. The current status for each Milestone is provided as Attachment 2. We look forward to continuing our work with you and the OCD on the remediation of this release, and the ultimate approval of the SSI Closure Plan. 
