Dear Mr. Crawford:

A NMOCD inspector observed a reportable release at Vaughn A-15 Battery on Wednesday, January 17, 2017. Another visit today, January 19, indicated that the release has been partially removed. While NMOCD does not preclude the Responsible Operator from any immediate clean-up activities, such as picking up standing fluids, further corrective actions will be necessary.

Per NMAC 19.15.29, NMOCD must be informed verbally within 24 hours of a major release (>25 bbls). Between 5-25 bbls of fluids, NMOCD must receive written notification on an initial C-141 form within 15 days. The C-141 for this release is due by February 3, 2018. Electronic submission is the preferred method.
