Dear Mr. Brunson:

As the average depth to groundwater from NMOSE database is <50 ft., NMOCD determines that further vertical delineation is required for 1RP-4407 to 250 mg/kg chloride levels and maintained for 10 ft. below.

TPH levels are not within permissible values at the depths indicated for excavation. NMOCD requests excavation to these levels with confirmation bottom and sidewall samples sent to laboratory for analyses before setting of a liner:

- SP1, SP4, SP5 to 4 ft. bgs
- SP2, SP6 to 3 ft. bgs
- SP3 to 5 ft. bgs.
