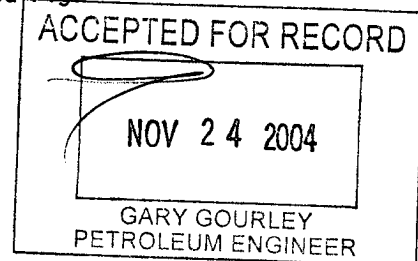

Drld to 4407'. RU csg crew and ran 98 jts 4-1/2" 11.6# J55 LT&C and ST&C csg. Set @ 4407'. Cmt as follows: Lead slurry - 850 sxs Halliburton Light Premium Plus. Tail slurry - 250 sxs Premium Plus. Circ 28 sxs to pit. Set slips, cut off csg, jet pits and released rig.
