Drill 11" hole to 3345'. Run 31 jts. 8-5/8", 32#, J-55, ST&C casing x 47 jts. 8-5/8", 24#, J-55, ST&C casing with 16 centralizers and set at 3340'. Cement with 1000 sx. Interfill 'C' (lead) and 150 sx. Premium Plus (tail). Plug down and circulate 99 sx. to surface. NU BOP x test blinds and annular. Drill out cement and resume drilling operations.
