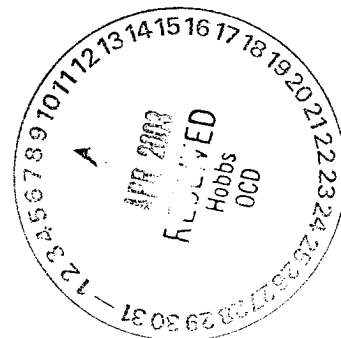

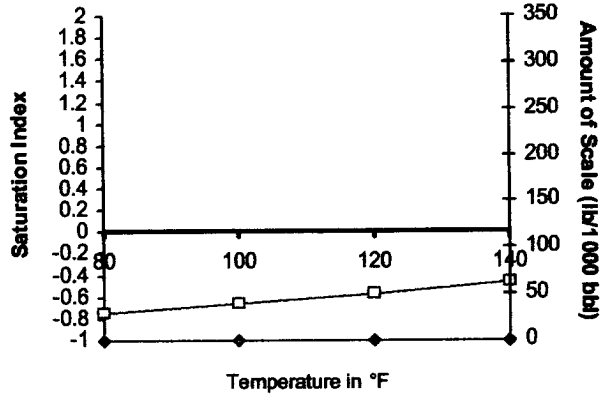

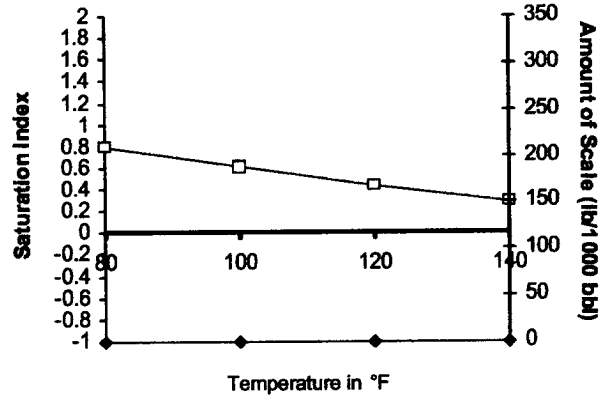

Analysis of Sample 210905 @ 75 °F for HEYCO, 5/29/02

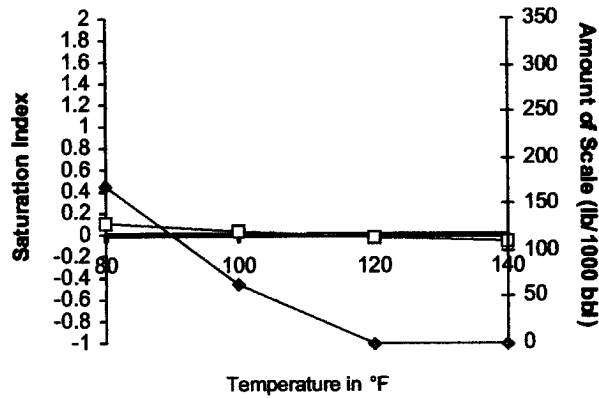
Calcite - CaCO_3



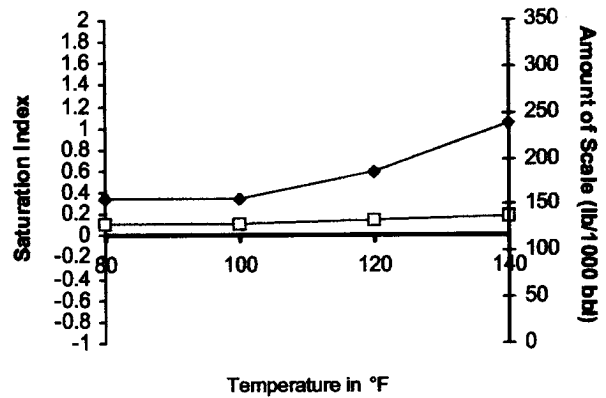
Barite - BaSO_4



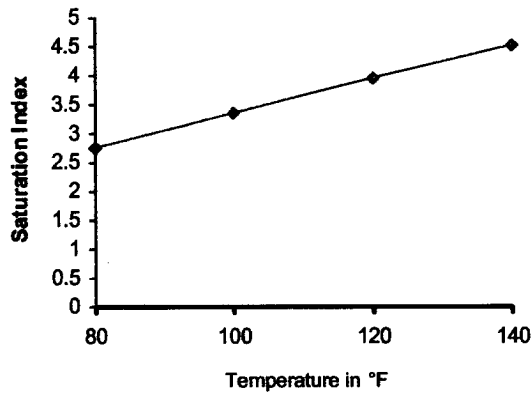
Gypsum - $\text{CaSO}_4 \cdot 2\text{H}_2\text{O}$



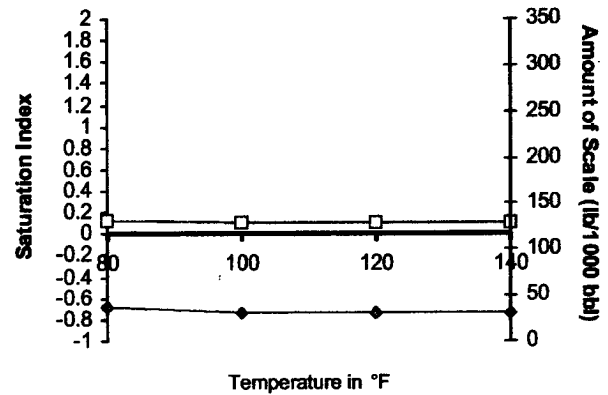
Anhydrite - CaSO_4
