We are requesting a Variance to pressure test our BOPE to 3000psi, due to the fact that we have a 5000psi BOPE on a 3000psi A section. Our Surface hole was drilled to 1621ft and a 3000psi A section installed topped with 10000psi rams and a 5000psi Hydril. Our Intermediate will be drilled down to approximately 5400ft, Once cased and cemented we will install our 5000psi B section and then test the BOPE to 5000psi prior to Drilling out the Intermediate Section.
