Ran Globe Energy's 4" nickel plated AS1-X pkr w/ 1.50 "F" profile nipple and on/off tool on 93 jts of 2 3/8" O.D., 4.7#, 8rd, EUE, J-55 seal lube IPC tbg. Set pkr from 3015' to 3021' (EOT) w/ 14 points of tension. Release on/off tool from pkr. Circ hole w/ pkr fluid, latch back onto pkr. NDBOP & NU, 7 1/16", 3K, x 2 3/8" slip type tubing flange + 2 1 1/16", 5K, full opening tbg valve.

2/25/14 - Ran MIT. Test for 30 mins; start pressure = 545#; ending pressure = 540#. Copy of chart is attached. Connect for injection.
