ConocoPhillips Company request permission to reroute and upgrade a flowline from the MCA 192 (located in the NESW of Section 25, T17S, R32E) to the MCA 4C Header (located in the SENW of Section 25, T17S, R32E).

The new pipeline will be a 2 1/2" Fiberspar surface pipeline approximately 2,124ft in length. The pipeline will have an operating pressure of approximately 30 PSI with a flowrate of 13 BPD (oil, gas, & water mixture).

The pipeline route will follow existing road corridors to keep surface disturbance to a minimum. The new pipeline route will also assist ConocoPhillips Company personnel in detecting possible leaks on the pipeline as soon as they occur.


