

### Subsequent Report for Form 3160-5

#### Drill Horizontal Lateral

##### 8/20/12 to 8/25/12:

1. Drill 12-1/4" hole from 1,750' to 5,530'.

##### 8/26/12 to 8/28/12:

2. Run 9-5/8" csg to 5,530' with DVT @ 3,537'. Cement 9-5/8" csg with 4,527sx. Ran TS. TOC @ 665'. One-inched cement to surface with 40 bbls.

##### 8/29/12 to 9/07/12:

3. Drill out from 9-5/8" csg (5,530'). Drill 8-3/4" pilot hole to 11,130'. Log pilot hole back to intermediate casing shoe (5,530').

##### 9/08/12 to 9/16/12:

4. Plug back pilot hole with 521sx cement. Dress off kick off plug. Attempt to kick off cement plug. Unsuccessful. Set OH whipstock @ 10,426' MD.

##### 9/17/12 to 9/24/12:

5. Drilled curve from 10,426' MD to 11,314' MD (8-3/4" hole).

##### 9/25/12 to 10/05/12:

6. Drilled 8-3/4" lateral from 11,314' MD to 15,702' MD.

##### 10/06/12 to 10/10/12:

7. Condition hole, LD DP and run 5-1/2" production csg. Set 5-1/2" csg @ 15,702' MD and cemented with 2,190sx. Circ'd 65 bbls cement to surf.

##### 10/11/12 to 10/12/12:

8. Nipple down, set slips, and cut off 5-1/2" csg. Release rig. RD MO drilling rig.
