6/12/17 1st stage: Cement lead w/ 300 sx Lucem, 10.8 ppg, 2.44 CFS yield; tail w/ 2416 sx Class H, 15.6 ppg, 1.22 CFS yield. Did not circulate. WOC 6 hrs.

Pumped 2nd stage via bradenhead w/ 80 sx Class C, 14.8 ppg, 1.45 CFS yield;

1835 sx Lucem, 10.8 ppg, 3.03 CFS yield. WOC 8 hrs.

Top out cement w/ 27 sx Class C, 14.8 ppg, 1.45 CFS yield. Circulated 2 bbls cement to surface. WOC 4 hrs.

Tested casing to 2860 psi for 30 minutes. Test good.

Resumed drilling 6-3/4" hole.
