COG Respectfully requests authorization to construct two buried 8-inch steel gas pipelines to tie in the CTB No. 2 (N) and CTB No. 3 (O) to the ETC buried gas pipeline. The buried pipelines on federal lands will be 40 ft.(0.008 mile) in length and 30 ft. in width for a disturbance of 0.028 acres each. The buried pipelines will be in section 25, T. 25S., R. 33E. This will be within the existing disturbance of the CTB pads and three pipeline rights-of-ways that are side by side. No new disturbance will be encountered. It should also be not that Bob Ballard gave a verbal to go ahead and lay the two small tie-ins while the ditch was open.

This should be covered in the Archaeological survey for the pad and three pipeline rights-of-ways, however, a consultation with the Archaeology specialist will be conducted.
