Change the BHL to 50' FSL 995' FWL, Sec 2, T23S, R33E, Unit M.

Change Drilling Plan as follows:

Drill a 17-1/2" hole to 1075' with Fresh Water. Run 13-3/8", 54.5# J-55 casing and cement to surface. Drill a 12-1/4" hole to 5200' with Brine, and run 9-5/8", 4300' of 40# J-55 plus 700' of 40# L80 and cement to surface. Drill an 8-3/4" hole to KOP at 8960' and drill an 8-3/4" curve and lateral with cut brine to approx. 14,460' MD. Run 5-1/2" 17# P110 casing to TD and cement in one stage circulating cement to 4400'.
