6/1/2020 Cleaned location and dug out cellar. Move in rig up and move in remaining equipment. Pumped 10 bbls fresh down the casing and the 5 ½" casing loaded. Repaired 5 ½" casing due to bad collar on the top. Installed 5 ½" X 8 5/8" wellhead and the BOP. Made gauge ring run and sat down at 29'. Picked up bit sub with 4 ¾" bit and tagged up at 29'. Rotated down with tongs to 32' and stopped making hole. Installed stripper head and washed and rotated down to 136' and stopped making hole. Believe there is collapsed or parted casing at 35' to 40'. Were able to work through but have to rotate through every time. Called OCD and shut down.

6/2/2020 Moved in reverse unit. Tagged up at 136'. Worked through bad casing until 348' and fell free. Tagged up again at 437'. Drilled down easily to 603' and fell free again (assume scale). RIH to 3205' without further issue. Rigged down reverse unit. Circulated MLF and spot 25 sx cement at 3205'. SION

6/3/2020 Tagged cement at 3040'. POOH to 1427' and spot 55 sx cement. POOH and SION.

6/4/2020 Tagged cement at 934'. POOH and spot cement across bad casing from 349' to surface. Took 90 sx to get good cement from the 5 ½" and 8 5/8" casing heads. Rigged down. Dug out and cut off wellhead. Filled both strings with 25 sx cement. Installed marker, removed the anchors, and cleaned the pit.
