A TRENCH WILL BE DUG & LINED WITH A IMPERVIOUS 20 MIL. LINER AND THE EXCAVATED MATERIAL WILL BE PLACED ON TOP AND ENCAPSULATED. PIT WILL THEN BE BACK FILLED AND CONTOURED WITH 3' OF SOIL CAPABLE OF SUPPORTING NATIVE PLANT GROWTH TO PREVENT EROSION AND PONDING OF RAIN WATER.
