RIH with tubing to 8300' - spot 40 sxs cement - WOC & Tag.
Pull tubing to 6200' and spot 40 sxs cement - WOC & Tag.
Pull tubing to 5100' & spot 70 sack cmt plug from 5100' to 4900' - WOC & Tag.
Spot 35 sxs cement at 2500'. *over Top SALT*
Spot 35 sxs cement at 465' - WOC & Tag.
Spot 20 sxs cement for surface plug.

add plug base of salt @ 2470'

Cut off wellhead and deadmen anchors. Get GPS coordinates and leave well cut off below ground level due to cultivation in the area.
File all NMOCD paperwork. Clean location.

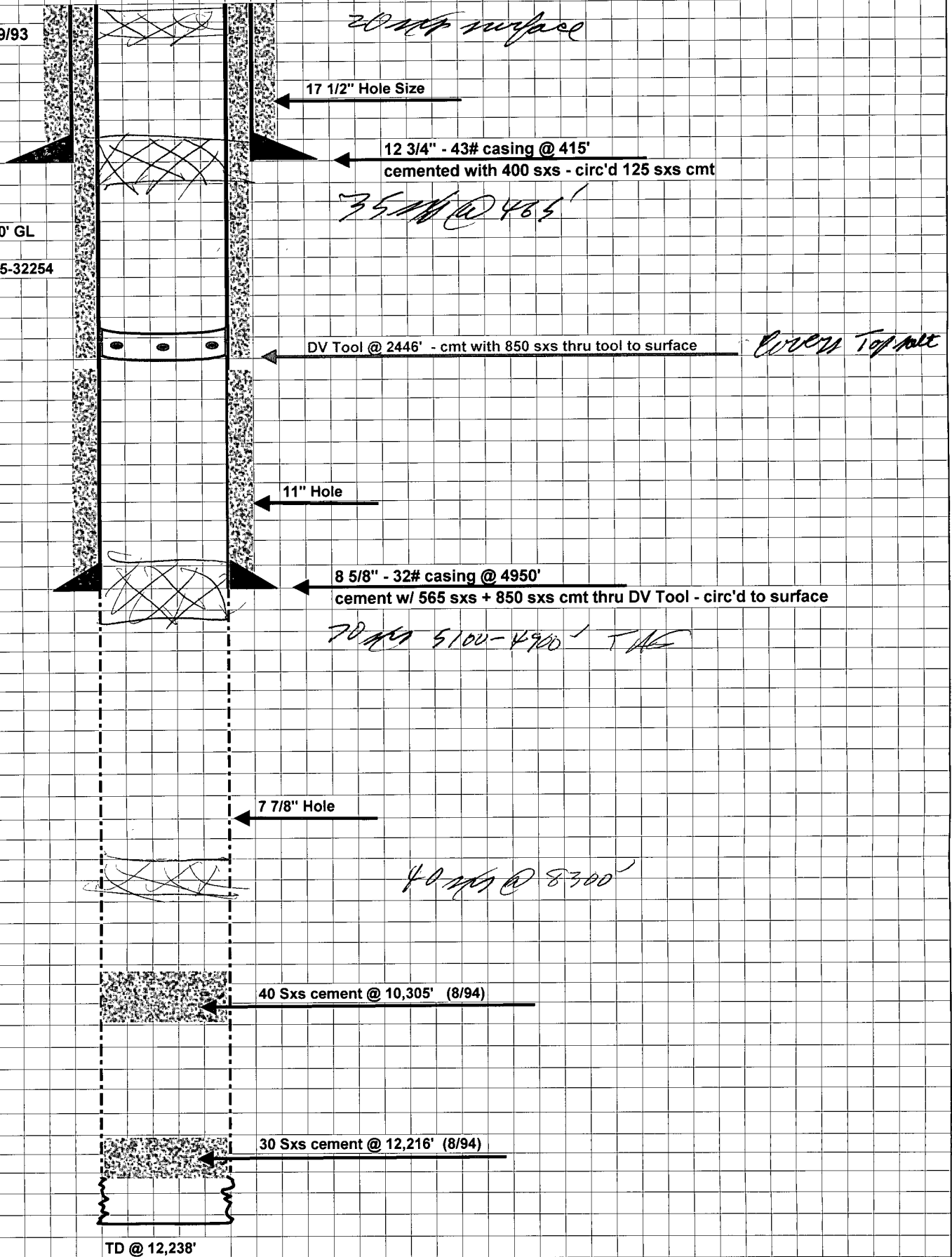
