1/16/08 RIH w/ WL and perf'd csg. @ 1850'. RIH w. 4 1/2 packer. Set @ 1500'. Pressured up to 1500 psi. Spot 25 sx cement plug @ 1900'. POH w/ tbg. WOC 4 hrs. Tagged plug @ 1575'. Perf. csg. @ 1035'. RIH w/ 4 1/2 packer and set @ 650'. Had hole in casing above packer. Set packer @ 472'. Sqz'd 60 sx. cement. Shut well in for night.

1/17/08 Unset packer. Tagged plug @ 502'. POH. Perf'd csg @ 60'. Put on swedge. Pumped 65 sx. cement down 4 1/2 and up 8 5/8 to surface. Cut off wellhead and weld on Dry Hole Marker. Rigged down move off.
