10/03/03 RIH & set 5 1/2" RBP @ 9012. Perforate 8521-8528, 8 holes; 8532-8552, 21 holes; total 29 holes.

10/04/03 Spot 250 gal 15% HCL over perfs 8521-8552.

Acidize w/ 1000 gal 15% HCL acid. Frac w/ 178,038 gal Angelmax & 91,040 # 20/40 Ottawa Sand

10/05/03 Latch onto RBP @ 9012'. POOH.

10/06/03 TIH w/ 2 7/8" tbg to 9308'. Ran 2 1/2" X 1 3/4" X 30' RHMB pump to 9308'. Place well on pump.

10/19/03 RIH & replaced pump w/ 2 1/2" X 1 3/4" X 25' to 8438'. Test well.

10/24/03 RIH & replaced 2 7/8" pump w/ 2 1/2" X 1 3/4" X 30' RHBC set @ 8342'. Test well.
