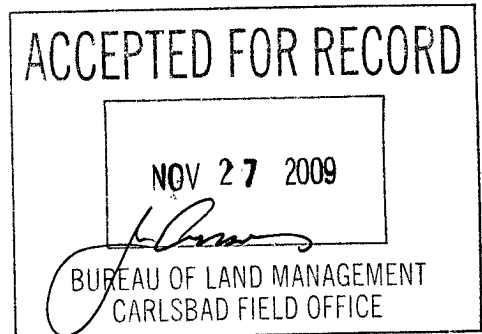
1. Remove flowlines, deadman, and all debris from location
2. Remove all caliche and contaminated soil from location and dispose of at J & L Landfarm
3. Place 1'-3' caliche barrier as needed on entire location
4. Place 1'-2' of topsoil as needed to sustain growth
5. Level and contour location on access road to surrounding area
6. Build earthen berm and access road entry to prevent vehicular traffic
7. Rip entire location and access road 6"
4. Seed all disturbed areas with BLM # 2 seed mixture using an approved seeder
