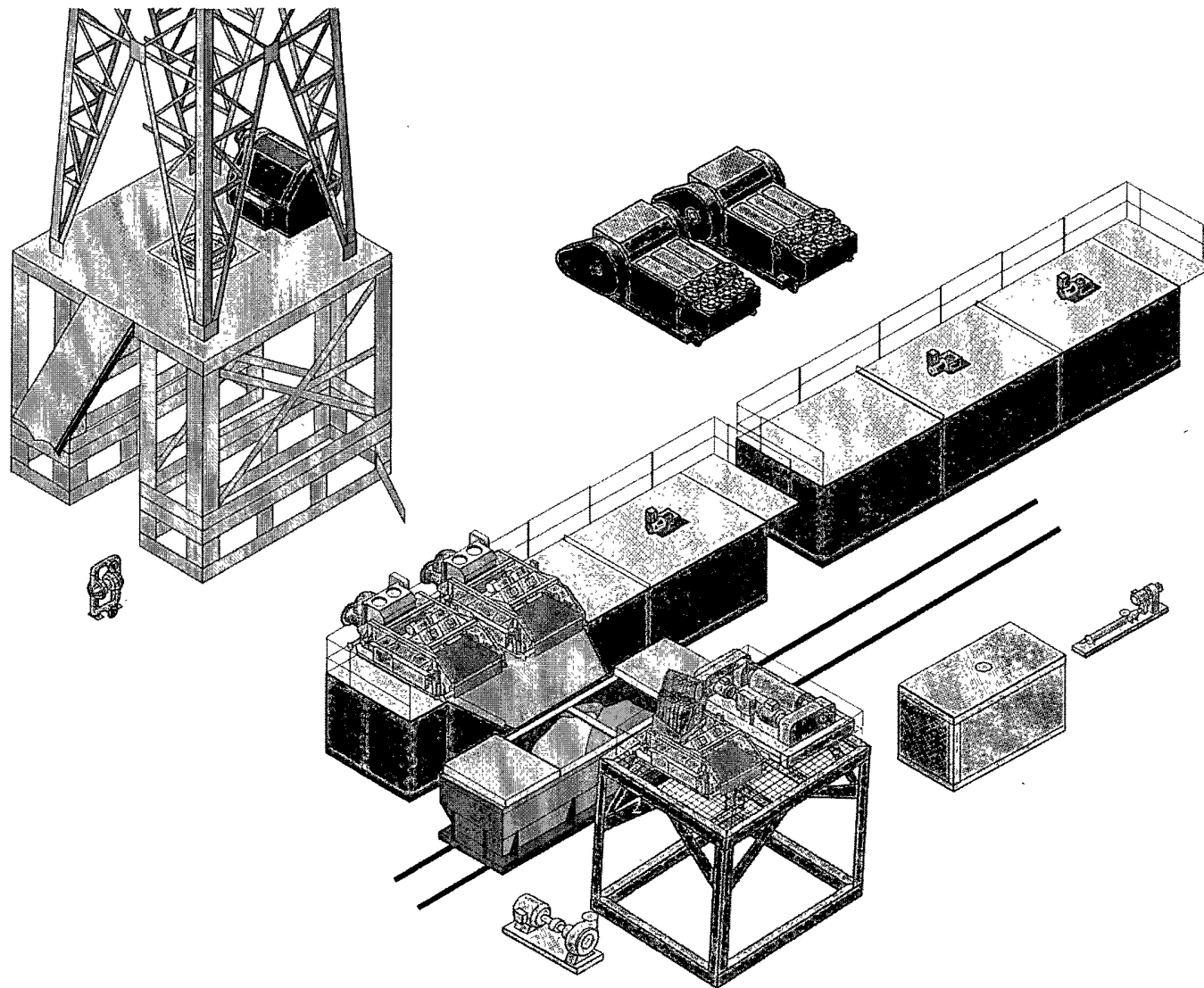
Dual motion shale shakers, solid removal centrifuges, one 500 bbl fresh water and one 500 bbl brine water frac tanks.

Any release or spill discovered will be reported to the NMOCD District I Office at (575) 393-6161 within 24 hours in accordance to NMOCD Rule 19.15.29 and Rule 116 NMAC.

Closure:

All circulating fluids and cuttings deemed for disposal shall be transported to the Gandy Marley disposal site, permit number NM-01-0019. An alternative will be the Sundance Disposal site, permit number NM-01-0003.
