25 sx @ 5448 (Glorietta)  
25 sx @ 4022 (8-5/8" shoe)  
Cut & pull 8-5/8" csg  
25 sx @ 8-5/8" stub  
25 sx @ 380 (12-3/4" shoe)  
10 sx @ surface  
Install dry hole marker per NMOCC regulations.
