7-5/8" casing pulled and well plugged by Mobil Oil Company
A 9-5/8" cast iron retainer at 4740 squeeze bottom of 9-5/8" casing (4840) with 100 sacks regular cement.
Spot 20 ft. cement on top of retainer.
Perforate with 4 shots per foot from 4525 to 4564 and from 4578 to 4600.
Acidize with 2000 gallons MCA then acidize with 4000 gallons 15% non-emulsifying acid.
This is San Andres formation.
