In compliance with New Mexico Oil & Gas Conservation Commission Order R-3153, we plan to re-enter this well and set a formation packer on tubing at 4196' to separate the Todd Upper San Andres "A" zone from the Todd Lower San Andres "B" zone. This well was completed June 2, 1964 flowing 2 MMCFGD from perforations at selected intervals from 4106' to 4186' in the Todd Upper San Andres and perforations at selected intervals from 4220' to 4248' in Todd Lower San Andres. After the packer has been set, the Todd Lower San Andres will be produced through the tubing and Todd Upper San Andres will be produced through the annulus.

## Instructions

**General:** This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.

**Item 4:** If there are no applicable State requirements, locations on Federal or Indian land should be described in accordance with Federal requirements. Consult local State or Federal office for specific instructions.

**Item 17:** Proposals to abandon a well and subsequent reports of abandonment should include such special information as is required by local Federal and/or State offices.
