Ran 304' of 13-3/8" 40# Seamless H-40 casing and set at 314'. Cemented with 300 sacks of Neat and circulated 75 sacks. Tested pipe and casing seat with 800 psi before and after the drilling out of the cement for 30 minutes on March 10, 1955, and both held OK.
