- 25 sack cement plug set @ 2525-2623' (BX @ 2574')
- 25 sack cement plug set @ 1512-1610' (TX @ 1610')
- 25 sack cement plug set @ 291- 385' (8-5/8" csg. @ 336')
- 10 sack cement plug set @ 0- 38' (set in surf. csg. w/marker)

A regulation marker was erected and the location cleaned up.


