(FOLLOW INSTRUCTIONS IN THE RULES AND REGULATIONS)

1. Pull rods, pump and tubing.
2. Clean out open hole to bottom using 4-3/4" bit.
3. Run gamma ray neutron collar log.
4. Run open hole caliper from TD to casing point.
5. Select zones from log and stimulate with 7500 gallons of retarded acid using open hole packer. Packer seat to be set from caliper.
