DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

8-5/8" 28# 8-thd. New Electric weld casing was cemented in this well at 2534' and cemented by the Halliburton Method with 485 sacks of cement.

Casing and fittings were tested with 1200# pump pressure and allowed to stand undisturbed for thirty minutes. Cement plug was then drilled out of casing and the same test again applied, no drop in pressure resulted so drilling was resumed.
