ADDITIONAL INFORMATION:

Will set 150 feet of 13-3/8 inch surface casing and mud it. Will set approximately 1600 feet of 8-5/8 inch casing to top of salt section and tack with 25 sacks of cement. If top of lime below base of salt is encountered at a favorable drilling depth, will pull 13-3/8 inch pipe, perforate the 8-5/8 inch and circulate cement to surface around 8-5/8 inch. Then will set 7 inch casing 200 feet in the line and tack with 25 sacks cement. If oil and/or gas is encountered in commercial quantities will perforate 7 inch and put sufficient cement back of 7 inch to bring it up above top of salt section.
