Cemented by Halliburton w/ 575 sacks of 2% Howcogel and 125 sacks of Portland bulk cement. Plug @ 6448'. Job started @ 1:30 a.m. and completed @ 10:40 a.m.

Propose to drill plug and test shut-off @ 10:40 a.m., August 27, 1949.
